

#### **XIV. AMENDED SCHEDULE OF EVENTS**

The following amended schedules are hereby adopted for conducting the elections, and supersede any dates previously published in the Election Regulations. The Election Board may revise the Schedule of Events if an election challenge, election dispute, court order, or other circumstances (such as a continued Tribal government shutdown) require a delay or adjustment to the dates listed herein.
