UPDATE: Higher Education & Adult Vocational Training Guidelines

Attention all Higher Education & Adult Vocational students! Please take note of the following important updates to the guidelines, **effective July 17, 2024.** The Tribal Council has approved the following changes that will impact undergraduate full-time students as well as AVT/diploma/certificate students:

1. The process for **receiving official/unofficial transcripts and account summaries** at the end of the semester/term for scholarship purposes has been **extended from 4 weeks to 8 weeks.**

2. In the event of a **life event preventing a student from meeting their academic goals**, a letter can be sent to the Higher Education Specialist for consideration to be placed into good standing and become eligible for scholarship.

3. Full-time undergraduate students can now receive a scholarship of up to 16 credits.

4. AVT/diploma/certificate students will now receive \$10 per clock hour.





Construction of 72 units Underway in Grand Traverse County for GTB Members

The Kchi-Noodin Kaamdaakiing development is 72.51 acres of trust property located off Herkner Road in Traverse City. First acquired by the Tribe in 2014 with a fee-to-trust application being submitted in 2016 and then accepted into trust in 2017.

Development of 16 Market Rental Units were constructed and opened to Tribal Member residents in October of 2019. Since then, the Housing Department has been dedicated to securing funding for additional units, specifically affordable, income-based housing, for the Grand Traverse Band Members who desire to live in Grand Traverse County.

Many applications were submitted with successful Low Income Housing Tax Credit applications being funded from the Michigan State Housing Development Authority, Competitive Indian Housing Block Grant applications being funded by HUD, GTB equity, and gap financing applicationsstillawaiting wordon award notices. 





ULTRAVIOLET RAYS SAFETY AWARENESS



Dr. Jessica A. Rickert, DDS, Anishinaabe Dental Outreach, is the first female American Indian Dentist, a member of the Prairie Band Pottawatomi Nation. She attended the University of Michigan School of Dentistry and practiced in private practice and at the Family Health Care FQHC located in Baldwin. She is an adjunct faculty instructor and preceptor at the University of Detroit Mercy School of Dentistry and University of Michigan School of Dentistry. She is also a past president of the Resort District Dental Society. She is the author of Exploring Careers in Dentistry, has written numerous articles, and has served as a speaker and consultant. She has been inducted in the Michigan's Women's Hall of Fame and is a recipient of the Ida Gray Award from the University of Michigan School of Dentistry.

LIP CANCERS

UV are Ultraviolet rays come from the sun and from sunlamps and tanning beds. There are two types of UV rays that damage human skin: UVA and UVB

Lip cancer is oral cancer that is of special concern to dentists. Lip cancer develops from abnormal squamous cells that grow out of control on the lips and on the skin surrounding the lips.

Lip cancer may not have any symptoms. What are signs and symptoms of possible lip cancer, which you should discuss with your dentist or doctor?

- A sore, blister, ulcer, or lump on the mouth that doesn't go away
- a red or white patch on the lip
- Cracked & bleeding that doesn't go away
- pain or numbness on the lips

Dentists are often the first to notice lip cancer during a routine dental exam. Lip cancer is highly curable when diagnosed early. Most sores or lumps on the lips are not cancer, though.

HOW CAN LIP CANCER BE PREVENTED?

- Minimize exposure to the sun between 10 a.m. and 4 p.m., the hours when UV rays are strongest.
- Apply lip balm with sunscreen 30 SPF before going outside. Re-apply every two hours, even on cloudy days & after swimming or eating. Some cosmetic lipsticks contain sunscreen. Consider using Zinc Oxide, although its opaqueness might be considered unattractive.
- Wear a wide-brimmed hat that provides shade for the entire face, including lips.
- Do not use sunlamps or tanning beds.
- Sand, concrete and water reflect UV rays, so cover up and wear sunscreen while outside. Snow and ice also reflect UV rays.
- Protect children from the sun, because skin damage from UV rays early in life can lead to skin cancer later in life. Keep babies younger than 6 months out of direct sunlight.

WHAT BEHAVIORS INCREASE THE RISK FOR LIP CANCER?

- Using tobacco products (cigarettes, cigars, pipes, or chewing tobacco)
- Heavy drinking of alcohol

- Prolonged exposure UV rays (both natural sunlight and artificial)
- Recognize that outdoor activities and outdoor work result in many

 Having light-colored skin

- Being male
- Havinghad the human papillomavirus (HPV)
- Being older than 40 years of age
- Living nearer to the equator

HOW IS LIP CANCER DIAGNOSED?

Dentists and doctors perform a physical exam of your lips and other parts of your mouth, head and neck to search for abnormalities. Dentists and doctors will also ask you about your:

- health history
- smoking and alcohol history
- past illnesses
- medical and dental treatments
- family history of disease
- any medications in use

SUSPECT LIP CANCER?

If lip cancer is suspected, a referral to an oral surgeon is in order. A simple biopsy can confirm the diagnosis. During a biopsy, a small sample of the affected area is removed. The sample is then reviewed in a laboratory under a microscope by a pathologist.

If the biopsy results confirm lip cancer, the oral surgeon and dentist and cancer specialist will determine the best course of treatment.

Remember, lip cancer is highly curable when diagnosed early. Because many cases of lip cancer are first discovered by dentists, it is important to make and keep regular dental appointments.

Stay Hydrated, Stay Safe: Effective Hydration Strategies for Hot Weather


Why Hydration is Crucial
